Virtual Capabilities

- CCSI has purchased Virtual Field Day Kits Tripods, Bluetooth Headsets and Mics, etc that can be shipped across the US; Available for use by partners working on soil health outreach.
- CCSI Webinar + Farmer Roundtable with Phil Needham (07/23-24) Virtual capabilities worked REALLY well. Phil was in a field in W KY, showing field conditions as well as equipment set-up and modifications combined with videos that were played remotely by CCSI. Based upon

attendance from across the US, this platform can provide a broader reach. This technology also provided a *different* way to hold event and provide education

- CCSI is providing support for Women4theLand Oversight Committee and a practice virtual event. This support will be available for future Learning Circles.
- Raft trip Arrowhead Country RC&D education committee puts on a rafting trip for area high schools every year; 2020 will be the 26th year for the event – held virtually with support from CCSI using Virtual Field Day Kits. There is a forestry section, a watershed demonstration, macro lesson, water chemistry, mussels and otters, as well as a scenic float on the Tippecanoe
- Advanced Soil Health Systems training targeting retailers. CCSI is working w/ TNC on this commencing with an August 10 virtual networking meeting.
- NOTE CCAs can get some continuing ed credits from virtual meetings. Keep in mind continue extending invitations, apply for CEUs

Soil Health Demo Kit Distribution

- Components have been purchased to expand soil health demo kits so that every county will have a full kit. To be made available for ICP staff, farmers and other partners.
- Everything is at the Vincennes University Ag Center and will be assembled on 07/31 with distribution soon to follow. ISDA staff will help distribute kits once they are delivered to NRCS Tech Team Offices.
- Trainings will be held on how to use the kits on hold for now; Still plan to have some kind of instruction whether in person or virtual.
- Suggestion: Consider demonstrations / using demo kits as part of PAC field days as topics

Soil Sampling

- Four Soil sampling and Interpreting Results trainings held Fall 2019. Attendees requested more advanced information.
- 2020 planned to be in person with a virtual option October 13, 14, 15 in-person (north, central and south); October 21 virtual. Note virtual training could provide good reference videos to be utilized throughout year.

- Every Indiana SWCD that applied for an NACD grant received funding. CCSI was funded as well. Success rate of funding speaks to Indiana's conservation efforts.
- Parke/Vermillion Received NACD grant to fund a staff person for 16 months and help supplement Carter Morgan's efforts. Also received funding through TNC to promote STAR

program and equipment.
