# **Highlights**

#### **New Program Manager Positions**

Telephone interviews were held, and five candidates were selected for in-person interviews to be held on Monday, December 19<sup>th</sup>. An offer was extended to and accepted by Julie Loehr for the SW Program Manager position. The NE Program Manager position was relisted and interviews will be conducted in Jan/Feb.

#### **New Agronomist Position**

As with the current CCSI Agronomist, the additional CCSI Agronomist will officially be a Purdue Extension position. In addition to soil health outreach and education, the Agronomist will be associated with Extension's Purdue-On-the-Farm program. Purdue On the Farm was launched over the past year and aims to connect its clients and partners through survey, field monitoring, demonstration, and on-farm research.

A draft agreement running from January 3, 2023, to September 30, 2027 was submitted for review with the Agronomy Business Department on December 13<sup>th</sup> and executed on December 21<sup>st</sup>. The position is expected to be listed in January.

#### **Strategic Planning**

An in-person Strategic Planning session was held on November 29<sup>th</sup>. A strong mix of partners attended the meeting (including Marc Roberts, Montgomery SWCD / IASWCD). An outline of program goals, strategic priorities, and measurements were developed. Finalization of the updated strategic plan will occur over the coming winter.

#### TNC "Mini-Grants"

An agreement is being developed with TNC to launch a mini grant program in partnership with CCSI. A total of \$40,000 will be made available to SWCDs and other Indiana Conservation Partners for soil health education/outreach projects, especially those that target Certified Crop Advisors and farmers who have not adopted soil health systems or are beginning soil health practitioners. More information will be made available at the IASWCD Annual Conference and a webinar scheduled for February 1<sup>st</sup>.

## The Root Project

All current graphic slides will have been made available for download from the CCSI website. Full-scale banners have been ordered and the first four have been received. Each CCSI Program Manager and Agronomist will have a full set. Partners may borrow the banners outreach and education events. A set is already scheduled to be on display at the Indiana Hort Conference. In addition, the South Dakota Soil Health Coalition asked if they could borrow a set for display at their Annual Conference to be held in conjunction with the Midwest Cover Crops Council Annual Meeting. A set will be on display at the IASWCD Annual Conference.

We have plans to develop a graphic featuring a ripper shank at full scale. Any source material – front and side view line drawings – would be GREATLY appreciated.

#### **IASWCD Annual Conference Breakout Session**

This session will focus on event planning, especially for those designed to educate community leaders: drainage boards, school boards, planning boards, local-state-federal elected officials. The CCSI Team will review event planning tips, tools, and survey templates. Led by Eric Shideler, Vermillion Co SWCD and with Dan Hovland + Kris Vance, NRCS – along with other SWCDs and ICP partners, much of the session will focus upon connecting with and providing education to community leaders.

#### 2023 Indiana CCA Conference

CCSI Agronomist Hans Schmitz and Indiana Soybean Alliance Conservation Agronomist (both Purdue On the Farm),

approached the Indiana CCA Conference planning committee to invite CCSI to participate in planning the 2023 event. That offer was accepted and members of the CCSI team will join in spring planning meetings.
