They have been interseeding cereal rye into corn; have some drone footage of that; partner with SWCD; Purdue Extension partnering with St Mary's watershed on a 5 year study, soil samples, water samples, Northern Adams county; Also working on a webinar series; 1<sup>st</sup> Thursday of each month starting in November, Water Science; December, Soil Fertility fertilizer, manure; January, Soil Health; February, Cover Crops; March, Dollars and Cents, April, some type of watershed topic.
- Field day in the works for Sugar Creek area Boone & Clinton counties, hopefully November, cover crop topic on Boone county plots – covers going in soon, also pollinator plots; virtual field day held last month, working on editing that and putting it on YouTube
- Morgan County Extension is planning a drive through field day on September 30<sup>th</sup>.

#### Root Project

- Graphics were sourced from a Dutch university cover crops dug up, washed roots, did
  drawings of them, Big Picture Studio created vector images for our use. These are free for
  download we ask that they not be used for commercial purposes, they are for education
  and outreach. Images are going to be used in some upcoming Northcentral SARE
  publications. There will be power point slides of these available soon as well.
- Dr. Ray Weil donated to CCSI in honor of Eileen Kladivko and her work with soil health. An email will be sent to those who have downloaded the graphics asking for donation.
- In other funding news, CCSI received \$100,000 NACD grant. Every SWCD that submitted from IN was funded. Recently received notification that we will receive full funding of \$120,000 requested.

## Virtual Field Day Kit availability

If your organization is doing something virtually that has a soil health component, we can ship equipment out to help deliver the message virtually. Items include: regular tripod, articulated tripod, smart phone adapter, tablet adapter, Bluetooth headset, lapel mic, portable charger, gimbles (camera stabilizer made for smart phones). #### Outreach and Education

- ICP leadership issued guidance on COVID while planning a meeting in mid-September. Reach out to Lisa, Sheila, or Jessica if you did not receive that document.
- Lais McCartney reported that SARE POW is due October 1 and includes a lot of soil health initiatives in it. She is hoping to hold Q and A sessions about 2 upcoming grants: Farmer Rancher grant due 12/5 for one farmer/rancher; youth educator grant about helping young people learn about sustainable ag principles; due in early November. NCR-SARE has a lot of resources that Lais can send to partners to pass out at your programs, if given enough time beforehand. Many can be sent from the SARE office directly to you. - Laura Fribley discussed the training and certification program. Employees around the state just
  wrapped up sending in what their training needs were and which were high priority, this should
  be ready for partner distribution soon. The last survey was done in 2017. This was reformatted a
  bit asking respondents to rank needs as high priority, some interest or no interest. Will be

posted on ICP website also. The top 4 needs by geographic area were also identified. Top rated topics statewide:

- 1. invasive species plants
- 2. backyard conservation and wildlife
- 3. pollinators
- 4. cover crops
- 5. weed ID
- 6. how to talk to producers/sell conservation (NOTE: The SARE 2021 plan includes a segment on communicating with farmers)
- Jessica and Sheila will be reaching out to CWI and 319 grant holders to see if CCSI can help execute your outreach and education deliverables.
- Clay, Vigo, Putnam, and Sullivan working on PHISH (People Helping Improve Soil Health)
- Daviess County Extension Trying to figure out how to do in person events. Virtual doesn't work for Amish clientele.
- Don Donovan Soil Health Demos video in Spanish. Editing now. Will be available in Spanish.
   Planning to do them in English as well. Had soil health trailer at 3-day Becks event. Crowd size about 1/3 of usual. Two additional soil health trailers will be constructed.

- Ancilla college has offered to give Marshall County SWCD a few acres to plant test plots, sample
  plots, open to the public as long as they are educational plots; no plans currently but looking for

  from their supplier you can order them and you can add your own logo to them
- IDEM received 14 applications for 319, currently reviewing applications; IDEM is developing a Lake Michigan watershed webinar series; starting soon, watch for information; October February, 1-2 per month; topics like IDEM NPS work; Stream and wetland mitigation; Federal Partnerships; Watershed groups, etc.
